



## COMPETITION RULES - BIORACER NV

Bioracer Staycation Secrets

(17/07/2020 – 15/09/2020)

### Article 1

The competition is organized by Bioracer NV, Ravenshout Z.5.2.50, 3980 Tessenderlo, Belgium.

Participation in the competition is free and without purchase obligation. The competition runs from Friday 17/07/2020 to Tuesday 15/09/2020.

The competition is open to everyone. Participation can be from anywhere in the world. The organizers of the competition and the jury are not eligible for participation in the competition. Children under the age of 16 must have a guardian's consent to participate in the competition. The guardian will accept any prize on behalf of the child.

The prizes cannot be exchanged for cash or for another product or service. If a winner does not want or cannot receive their prize, they will not be entitled to any form of compensation. Each person can only enter once.

Participation in this competition implies acceptance of these rules as well as any subsequent changes that may become necessary, for example due to force majeure. Participants will where possible be notified of such changes.

### Article 2

To participate validly in this competition, the participant must:
